- Biodegradable and non-flammable

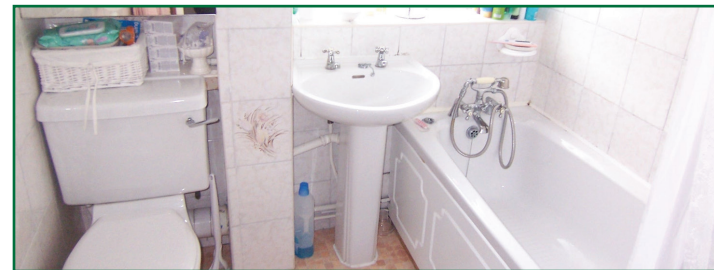

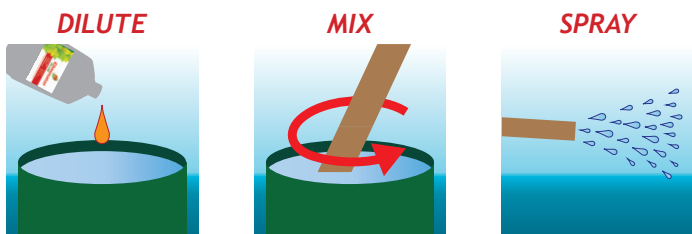


Major uses:

- As an **ODOR ELIMINATOR**, it neutralizes Ammonia, Hydrogen Sulfide and other offensive odors. It removes rather than masks foul odors. It leaves no offensive-smelling gases behind. Due to its odor eliminating capabilities, **EP** is able to remove odors that attract flies, and therefore lessens fly density.
- As a **DISINFECTANT/WATER QUALITY ENHANCER**, its potent anti-microbial action eliminates pathogens and other harmful microorganisms immediately.
- As a **COMPOST ACTIVATOR**, it accelerates conversion of animal waste into organic fertilizer (neutralizes a normally acidic environment).

General instructions and recommended usage:

- Dilute **ELIMINATOR PLUS** with water only when ready to use.
- Use a spray bottle, backpack sprayer or power sprayer to apply the solution.
- For general usage, 1 part **ELIMINATOR PLUS** should be diluted with 200 parts water (increase concentration levels as needed).

Product shelf-life:

- In its concentrated form, **ELIMINATOR PLUS** has a shelf-life of 5 years.
- When diluted, the solution must be consumed within 30 days for best results.

Precautions:

- **KEEP OUT** of reach of children.
- Upon contact of the concentrate on skin, flush affected area with plenty of water.
- If concentrate is swallowed, **IMMEDIATELY** drink plenty of water.
- Avoid concentrate from making contact with **LEATHER** and/or **ALUMINUM** materials.
- **DO NOT** use PET plastic bottles as a container for **ELIMINATOR PLUS** in its concentrated form.
